As a Zurich Park Caretaker, you will be responsible for the maintenance, cleanliness, and overall upkeep of the park grounds to ensure a safe and enjoyable environment for visitors. Additionally, the caretaker will reside at the home that is provided by the County at Zurich Park. The house and utilities will be provided by the county except for long-distance calls. The Caretaker will be responsible for having the community hall open when it is rented and having a fire prepared when needed. Salary will be negotiable depending on experience.
